

Consignor Agreement

By signing this "Consignor Agreement," I am agreeing to the terms and conditions for the Crafters' Exchange Consignment Sale, hereafter known as Crafters' Exchange.

1. I shall hold harmless and make no claim for damage, loss, theft, pricing discrepancy, or injury against Crafters' Exchange, its organizers, paid participants, volunteers, or establishment where the sales event is held for any item placed on consignment. Every precaution is taken to see that this does not happen during or after the sale. No compensation will be made for lost, missing, damaged, or stolen items. Any item not clearly tagged with a consignor number, or items that tags have fallen off of will be placed in a "lost and found." Items not claimed by Monday at 8:00 a.m. will become the property of Crafters' Exchange.
2. All items left in the possession of Crafters' Exchange are at the sole risk of the consignor. Consignor agrees that they will assume and bear all risks regarding items dropped off at the event and will hold Crafters' Exchange exempt from any and all liability, to include, but not limited to, theft, fire, wind or rain.
3. I agree to allow Crafters' Exchange to sell my items that were checked in, and that on the half-price sale date, all remaining items will be sold for half of the original price, unless your tags are marked with the "ND" (no discount) designation in the lower, left-hand corner of the tag.
4. I acknowledge my items offered to be sold are in good operating condition, with reasonable wear and tear, and are not defective, broken, or damaged in any way. Crafters' Exchange reserves the right to remove any items from the event due to wear, poor condition, stains, nonworking items, etc. These items may be pulled from the sale at any time, including after drop-off and during the sale.
5. I acknowledge that no item is the subject of any pending or threatened recall notice or other consumer protection action, and that I have reviewed the CPSC recall list (www.cpsc.gov) and no items being consigned appear on such list. The selling of recalled products could also carry civil and/or criminal penalties for the consignor. Consignor assumes all responsibility regarding recalled items.
6. I agree to read and follow all instructional guidelines for participation as stated on the Crafters' Exchange website.
7. I acknowledge that items remain my property until purchased by buyer. Crafters' Exchange does not take title to nor risk of loss of any item being consigned.
8. I understand that any remaining items not picked up at the designated pickup time listed on the Crafters' Exchange website will become the property of Crafters' Exchange, unless other arrangements have been made in writing in advance, and will be donated to a nonprofit charity. Items cannot be held or stored after the sale. If you are unable to pick up your items, make arrangements for someone else to do so, and make sure they have your consignor number.
9. I understand that prepaid registration fees are nonrefundable and nontransferable.
10. I agree to pay Crafters' Exchange 20-35% of the total sales amount in consideration for its work and services in coordinating, organizing, and promoting the sale event. I understand that I will receive an extra 5% commission in sales for every 4-hour shift worked, up to three shifts.

11. I understand that as a consignor, I am expected to help publicize the event as much as possible. I will help spread the word to all my friends and family and post the event on social media and help spread the word out to the community.
12. I agree to cash/deposit Crafters' Exchange proceeds check within 30 days of issuance.
13. I agree to not set up in business as a direct competitor of Crafters' Exchange within 75 miles of Smyrna, TN, U.S.A., for a period of 36 months (or 3 years).

Any and all provisions contained herein shall survive the Event.
